Imo Council Of Traditional Rulers Not Dissolved – Eze Ohiri

Chairman Imo State Council of Traditional Rulers, Eze Samuel Agunwa Ohiri, has dismissed recent media report of the dissolution of the council as false and grossly misleading, insisting that he is still in charge as Governor Hope Uzodinma has not sacked him and his team

Ohiri, who is the traditional ruler of Obi Orodo community in the Mbaitolu Council Area, told newsmen in his palace that at a recent meeting between Governor Uzodinma and monarchs in the state, that the former never made any pronouncement dissolving the council

He attributed the purported dissolution of the council to the activities of some mischievous individuals who are out to distract the governor from concentrating on his numerous programmes such as fighting the COVID-19 pandemic erosion control, payment of salaries, pensions and gratuities and insecurity.

"The governor did not come to the traditional rulers in the state to announce the dissolution of our council and he was careful in order not to be misquoted and so he has not dissolved our council but some people out of mischief, are flying the kite and it is just unfortunate".

The monarch, however, admitted that his office is tenured and that the governor has the right to dissolve them whenever he deems fit.

Railway Workers Canvass Removal Of **Tinubu's Name From Station**

arely 72 hours after President Muhammadu Buhari renamed several railway stations after some prominent Nigerians, workers and union in the Nigerian Railway Corporation (NRC) have agitated for the expunging of Asiwaju Bola Tinubu's name from one of the beneficia-

ries. The union; Nigeria Union of Railwaymen (NUR) in a statement by Mr. Segun Esan, its Secre-

tary-General, demanded that the Apapa Railway Station, which was renamed after Tinubu be reversed to its original name Waziri Mohammed Railway Station.

The union also lamented that Mr. Rotimi Amaechi, the Minister of Transportation did not consult with the either workers or the union before submitting the names of the beneficiaries to President Buhari.

Esan, however, said that the union harboured no ill-feelings against any of the beneficiaries whose names were approved by Buhari, but said Waziri who among other 117 persons perished in the Bellview Airline crash of October 22, 2005, at Lisa in Ogun State, already had the Apapa train station named after him by the government and wondered why the name should be replaced.

Until his demise, Waziri was the Chairman of Nigeria Railway Board. He died in the Bellview's plane crash just 24 hours after visiting the railway office at Ebute Metta in Lagos on official assignment.

The statement said: "To this effect and without prejudice to any of the distinguished personalities whose names have been given to railway stations by the Hon. Minister of Transportation, we strongly demand that the name of Apapa Railway Station be reverted to its old name, Waziri Mohammed Railway Station.

"Apapa railway station, after the painful death of our beloved Late Alhaji Waziri Kyari Mohammed in a Bellview plane crash, which occurred on 22nd October 2005 at Lisa in Ogun State, was most officially named after him who until his untimely death was the Chairman of Nigerian Railway Board.

Lalong Signs Plateau **Revised Budget Of** N122.8bn

Plateau State, Governor Simon Lalong has signed into law the state's revised 2020 budget of N122.8 billion for the fiscal year.

He said demands for funds to carry out statutory responsibilities and also respond to the challenges of the coronavirus pandemic made his government to engage in various cost-cutting measures to enable it manage the lean resources efficiently and also "fulfill our most basic responsibilities of providing services to the citizens."

Lalong added that the revised state budget consisted of 42.8 billion for capital expenditure and 79.9 billion for recurrent expenditure..

THAT A THIRD KING WILL NOT BE KILLED IN EVWRENI KINGDOM

The previous and the present crises in Evwreni was, and is, a product of ambers of discord that were fanned and are still being fanned by persons who were, and are still never in concord with the decision of the Supreme Court in Chief Utuedor Utih vs Chief Jacob Umurhurhu Onoyivwe (1991) 1 NWLR (PART 166) PAGE 166 AT PAGE 203 wherein Mohammed Bello, JSC as he was then, declared as null and void the competence of any Court to question the selection, appointment, grading and payment of stipends/or salary to Chief Jacob Umurhurhu Onoyivwe as the Ovie of Evwreni. When Chief Jacob Umurhurhu Onoyivwe died, Evwreni Kingdom in accordance with its native law, custom and usages, appointed Chief Irobogo as reagent, Chief Utuedor Utih again sued Chief Irobogo on the same issues, subject matter and party. This case progressed to the Court of Appeal, Benin City. The Court of Appeal, Benin Division decided that the later case is gross and crass abuse of the judicial process, since the Supreme Court has decided this same case in Utih vs Onoyivwe Supra (as above referred). For emphasis and for the records, when Chief Jacob Umurhurhu Onoyivwe the beneficiary of the Supreme Court decision died, after the regeancy of Irobojo had expired, His Royal Highness Owin Kumane Eruvwedede II, was validly selected by the Eruvwedede Ruling House and presented to the entire Evwreni Clan. His selection was duly approved and he was coronated by the King Makers, consequent upon which a Staff of office was presented to him by the Governor of Delta State. From the moment when His Royal Highness Owin Kumane Eruvwedede II, was crowned and presented with a Staff of office, both peace and harmony evaporated like the dew at the zenith of harmattan blight. The king was wrongfully accused of embezzling money; an amorphous sum of N6,000,000.00 (Six Million Naira) purportedly paid by the Shell Development Company of Nigeria Limited to Evwreni Community without documentation. The Royal Father was equally accused of conspiring with the Nigeria Police Force to kill some young men of Evwreni extraction. Both accusations were imaginative, fictitious and false but were designed to create an evil impression to get at the king. In point of fact, no such N6,000,000.00 (Six Million Naira) or any amount of money at all lawfully due and payable to Evwreni Community by Shell was paid to the king nor did he act alone or conspire with the Nigeria Police Force or any person anywhere to kill any indigene or a stranger living within or outside Evwreni Clan. It was this same N6,000,000.00 (Six Million Naira) said to have been allegedly embezzled by the King that was subsequently paid by Shell to the caretaker/ peace committee appointed by Evwreni Kingdom, then headed by Chief Jacson Udi of blessed memory, that was spent to build the present Community Town Hall: after His Highness Owin Kumane had been murdered in cold blood!.

Also on the cooked up accusation of murder of young men in the Community, the truth is; honest and right thinking men who were resident in Evwreni knew that Owin Kumane Eruvwedede II, emerged as king at a time when a group of dissident men of negative influence resisted everything lawfully done by the king. The insubordination of the dissidents caused total breakdown of all known fabrics of native law and custom, usages, norms and values leading to lawlessness, robbery, banditry and rapping of house wives, by young men. it was the evil-inclined young men that killed the then youth leader Comrade lwhreko and his Secretary at their different home on same day and set them and their homes ablaze.

To reverse the siege of bandits on the Community, the King immediately set-up a new youth executive lead by Mr. Agbaghara Jonathan who was supported by many other courageous young men such as Messrs Young Abodo, Prince Ochuko Kumane, Owhe Clever, Prince Matthew Uba, Blessing Okri and Samuel Mariere, the later became a member who represented Ughelli Constituency 1 in the State House of Assembly for two terms. As it would be expected, the principal task of the new executive was to stop the bandits who were on rampage. To this end, the said executive engaged the services of the Nigeria Police Force and it worked assiduously with one police Inspector Sanni and another Police Officer, Egbe of blessed memory. The result was a lot of the community boys who were involved in robbery, killing and arson were successfully arrested and handed over to the police, many of them who engaged the police in fire duel died in the process: Can the late King be validly accused of killing innocent youths by ridding the community of bandits by using the youth executive which worked in concert with the police?

It has been established that the late King Owin Kumane was killed for no justifiable reason; for the alleged N6,000,000.00 (Six Million Naira) said to have been paid to him that he embezzled, was never paid by Shell to him or anybody else as at the time the king was killed. The charge of killing innocent youths also collapsed from the facts adumbrated above, as those youth who died in the hand of the police on account of cross fire, were robbers, rapist and arsonists. It is correct to conclude that Owin Kumane was killed by conspiracy of group of people and this conspiracy still continue today to undermine the peaceful reign of his son who succeeded him; the Current King: His Royal Majesty Oghenekevwe Owin Kumane, Eruvwedede III.

Bright Adjogbe, the elder brother of Engr. Samuel Adjogbe contested the position of President General of Evwreni Clan Improvement Union. The election eventually held on the 22nd of October, 2019. Of the ten elective positions for which election was to be conducted, it was only the position of the President General that election was conducted and separate results were returned for the position of President General. It was on the basis of the inconclusive election and in order for the need to maintain

peace, law and order, amid threats by some people, that the Evwreni Traditional Council headed by His Royal Majesty, Ovie of Evwreni set up Elders Committee comprising of men of proven integrity who are Gen. Oviemo Ovadje (Rtd), Evang. S.O. Olutu, Mr. K.K. kumane, Engr. James Asakpa, Mr. Ochuko Dafiawhare amongst others, to resolve the political impasse.

The foregoing elders committee then resolved that as Collins Udi the second President Candidate has given them his blessing to bring peace, Bright Adjogbe should be allowed to form his cabinet with men of his will for the term of three years while his opponent at the election, Chief Collins Udi should be allowed to rule for three years thereafter. It is this gracious tenure of three years commencing on the 2nd November, 2019 that Bright Adjogbe is using in exercising maximum force.

Insubordination to constituted authority reared its ugly head so soon after Mr. Bright Adjogbe has by proclamation vide the doctrine of necessity brought to office by the Elders' Peace Committee. In July 2019, the Ughelli North Local Government Chairman acting in concurrence with the Divisional Police Officer, 'A' Division Ughelli requested the Seven Kingdoms in Ughelli North, namely: Agbarha Kingdom, Agbarho Kingdom, Evwreni Kingdom, Ogor Kingdom, Orogun Kingdom, Uwheru Kingdom and Ughelli Kingdom to reduce the names of persons in the list of the respective Vigilante Group each Kingdom had submitted from thirty (30) to twenty (20) persons. Bright Adjogbe on becoming President General got wind of this proposed alteration to the list. When the king, His Royal Highness called Mr. Bright Adjogbe that the list is his prerogative, he challenged the king to produce a documentary evidence of such authority. It took the intervention of the Local Government Chairman and the said DPO before Bright Adjogbe let go his caustic opposition to the list of the twenty (20) fit and proper persons which the king submitted. One does not need the clairvoyance of naustradermous to be able to unravel that raising a parallel vigilance group can compromise the king security, and make him vulnerable in the event of an attack. It should be recalled that the father of the current king Owin Kumane was attacked by Vigilance Group that killed the king on Thursday, 20th January 2000 at 12:37pm. Sometime last year, the elephant tusk, one of the symbol of the King's authority that went missing over thirty years ago was found in a woman's house. What a mystery.

It is also a diversionary play to claim that it was some persons from Evwreni community that attack personal aides of a prominent engineer on 20th of June, 2020 on the East–West Road close to Evwreni. The truth is, some suspected Fulani bandits attacked various persons on the same spot on that day. It is on record that the King of Patani was one of the persons attacked on that day, even Hon. Samuel Mariere as well as the Chairman of Agadama Community of Uwheru Kingdom was also attacked on the same spot. It therefore, came to everybody as a surprise when the engineer turns the story to a failed imaginary assassination attempt on his life.

To sustain the charge of criminal attack, the police were brought with intent to arrest detain and keep out of circulation every voice of dissent and to undermine the king. The following persons namely Mr. Ifaka Hero, Mr. Stephen Atiri (a.k.a. Actor) and even the lawfully appointed vigilance group Chairman, Mr. Tuesday Okwa, were the persons who were threatened with arrest. It was the insistence of Mr. Tuesday Okwa that both the Divisional Police Officer "A" Division Ughelli and the Police Area Commander, Ughelli Area Command be called first by the Police to confirm his arrest, which the police could not do, that delayed their "false" arrest. The king Oghenekevwe Owin Kumane who was returning from a journey met the police and Okwa arguing. The amiable king intervened, pleading with the police that he should be allowed to produce by himself whomever that they want in his domain. In opposition, one of the masterminds of the operation stood his ground and rain insults on the king saying that "the days of the king and his end shall be more tumultuous than that of his late father". The above quoted sacrillegous utterance was responsible for the attack by the young men at the scene on the speaker, who immediately ran from the scene to gather some of men in the terrorist group to launch an unprovoked attack at the palace by firing gunshots at the King's car at the palace gate.

The said unprovoked attack was repelled by some youths who were attracted by the gunshot to the palace. The king came out of his palace and pleaded with the youths in the company of Honourable Victor Ohare that they should not go and fight. While the king was pleading that peace, law and order be maintained, some other youths brought before the King a notable person who was armed with a locally made gun; and who confessed on camera that the gun in his possession was shared to him to go and attack the King's palace. To avert crises, HRM Oghenekevwe Owin Kumane pleaded once more with the irate youths not to kill the man but that he should be handed over to the police. The king instructed the Vigilance Group Chairman, Mr. Tuesday Okwa to call the DPO 'A' Division Ughelli who sent some policemen to whom the king handed over the man and his locally made gun.

It may interest the police to know that the subject has made useful statement to the police indicting the killers of Sylvester Adjogbe as he was present at the scene of the killing. It should be noted further, that the vehicle, and every other equipment including guns and bullets used by the Community Vigilance Group were bought for them by some persons who, till September 2019, were paying the Vigilance Group Members monthly salary. The relationship between members of the Vigilance Group and their sponsors became strained when despite the tromogous amount of money spent on the members, they remain resolute and vehemently refused to join hands with him to fight the King. It is on the strength of this miserable, sordid and morbid facts adumbrated above, of a king under siege and in a state of annihilation, in the hands of his subjects who are wealthy and very powerful and who boasted that the reigning King HRM Oghenekevwe Owin Kumane III "that the days of the king and his end shall be more tumultuous than that of his late father" who was murdered in cold blood on Thursday, 20th January, 2000; that we now politely but urgently urge you to use your good office to plead with the sponsor to reign in on his attack dogs at Evwreni in order to sustain the fragile peace, law and order so as to avert the killing of another king. We thank you profusely in anticipation that you will act on this petition to avert the killing of another innocent king as well as to protect the lives and properties in the Kingdom.

6.30pm on Tuesday, an explosion occurred, which made residents scamper for safety. According to him, the explosion occurred when the seller was dispensing gas to a customer during which time a spark from the welder's end triggered the explosion that resulted in the fire, killing four persons.

Onwuchekwa said, "This explosion shocked the very foundation of Ajao estate resulting in the burning of the high tension cable. You can see that building under construction, it caught fire. A lot of other properties were affected, lines of shops were destroyed. The swift arrival of officials of Lagos State **Emergency Management** Agency (LASEMA), and men of fire service helped to put off the fire. It is unfortunate that we lost Victor, the tailor. Mama Funke and her granddaughter, Funke and a customer who came to buy gas. I must say that over four persons died in that explosion because the tailor has boys working for him and we haven't seen any of them. Some many people have lost properties worth millions of naira. My property was also affected' At the time of filing this

report, men of LASEMA and Lagos State environmental protection agency were seen evacuating remains of the deceased, some of them in bags, burnt beyond recognition, even as the scene was cordoned off.

Tricycle Operators Protest Alleged Police Extortion In Ughelli

ricycle riders popularly known as Keke operators in Ughelli North Local Government Area of Delta State on Wednesday besieged the Ughelli Area Command of the Nigeria Police in protest of alleged extortion and arrest of some of their colleagues by men of the force.

The operators numbering over 1,000 with their tricycles alleged that the police officers were collecting between N5,000 to N40,000 from alleged violators of a new directive by the state government which placed a ban on the operators from plying Federal roads in the state.

The Delta State Government, through the Ministry of Transport, has barely announced the ban on Monday, July 27, 2020, when men of the Area Command started arresting and collecting money from the operators, some of who claimed ignorance of the new directive. Speaking on behalf of

the protesters who also barricaded the East-West and Isoko Road, causing gridlock for hours, Pastor Sunday Okorie, said the protest was over the challenges they faced with series of government directives that tended to hinder their operations.

Okorie said, "During this COVID 19 period we have been restricted to carry only two passengers, meanwhile some of us are balancing between N1.2 million to

N1.5 million for the Keke, so it is already difficult for us to meet up with the new directive, but yet we are complying.

'Now the state government has come up again to say we should not ride on the federal highways. And these highways are the major roots of some of our colleagues. Second, the police are already capitalising on this new directive to arrest and extort money from our people. As soon as they see a Keke rider on the road even though he just wants to turn to the other side of the town, they would arrest him.

They are now telling us that we cannot cross over to other parts of the town with our keke. Somebody from Afiesere or Upper Afiesere, for instance, cannot cross to Mission Road and other parts of the town, they will iust arrest him. You don't just make laws suddenly and start prosecuting people without any prior notice or engagement.

Okorie added, "We want the state government to first of all look into our plight and consider reversing the decision because inside the town is saturated with Keke and there is no way you can meet up if everyone is riding within the town alone. We want the government to properly define the directive because, Ughelli, for instance, is divided into two parts and it is separated by

Nobody Should Attempt Playing Games With Edo Election – Obaseki

Governor Godwin Obaseki of Edo state, the Peoples Democratic Party (PDP) candidate in the September 19 governorship election, speaks with journalists on latest developments in the state, why he is seeking reelection and other issues. **TEMIDAYO AKINSUYI** brings the excerpts:

In this part of the world, having a good candidate and programme is not a guarantee for victory. Besides, the Edo people in the Diaspora will not vote during the election. Don't you think you need to play the Nigerian politics than the politics itself?

What happens is this-Nigerian kind of politics is one that is created. You know there are different motives for different things. It is election time now and I begin to brag my own truth or story about politics, about who I am and who I am not. Today, in Edo, this is what is on ground – Edo is dearly a PDP state. It has always been. The PDP has won every national election and the APC only won local elections. So, in terms of the political configuration of the state, at best you can say it was 50-50. Who is APC? I am the state governor. And in that side, (Adams) Oshiomhole does not have control of the APC structure. But, I have it. All the local chairmen, members of the house and all the councillors. So, in terms of the political structure, I believe I have at least 75 per cent of it. So, it is now 75 per cent of APC and 50 per cent of PDP in the new configuration. So, if that can't be, I don't know what can be then. Then, come to the people, yes as politicians, we make our noises but at the end of the day, voter turnout is very low in Nigeria because for most people, 'what is my own I don't have any business with it and I don't have a stake except what you give me for me to go and vote because after that I won't see you. There is very limited connection between the people and the government. So, why go and vote? Why participating? Only politicians participate in the political system'.

What we have done in Edo in the last four years is remarkable. It is by providing services to people. You now begin to feel a connection with government. I have 300,000 children in my school system. I spend an average of about N16,000 on each of them on Edo Best. The parents, who are poor, are seeing a difference in their children. The teachers are now calling, giving their pupils training. So, the parents of the 300,000 children don't matter? They see a connection with the government and they are getting something now. So, would they just allow it walk away? Would they now not participate? I tell them that If I am not there, those children will not get these services anymore because they will take the money. What about the pensioners? What about the civil servants who knew what their situation was before now? You think they will just keep quiet and allow? Look, in Edo today, I have what is called Ward Development Committees, where in every ward,

there are 17 or more than men and women who live there and consider themselves as a committee.

You have maybe a priest, a native doctor, a teacher, a retired teacher, a retired nurse and so many others. People just live in the community, meet regularly and I have asked them to talk about and bring up issues because the local governments are not strong. So, they do let me know what their priorities are. And I have them across the state. And the amount of digital penetration is amazing. What about my school-based management committees? So, you have those committees that are very very active and alive. My own view though in all of these is that if all don't matter in the political system and these guys have enough instrument of arms to come and rig out the majority, then it is unfortunate for the system. But, I can assure you that Nigeria will never be the same because Edo is not in one extreme. And with the crisis and tension in the country, anything that sparks in Edo, only God knows the effect.

So, I hope and pray that people are sensible enough to know that with the level of digital penetration; with the effect of COVID-19, we must now begin to think and think properly. I am now in PDP. It is not like heydays. There is a structure at the moment. Do they want to retain me in government house? I believe so. Do the people who are in APC want me to still be there? I believe so. So, who are these opposition? The opposition is that tiny army of Oshiomhole's boys, not major political players of repute.

Do you think you are capable of challenging taming politics of violence because those boys you just talked about have a role to play on that Election Day? We will not talk about that. Nobody has monopoly of violence. You know you don't want to go that way. With Edo coming into PDP, the South-South is full completely. Even if I don't have the capacity for thuggery, I have enough neighbours and brothers.

We know about the usage of federal might and the Independent National Electoral Commission (INEC) to win elections. So, the question is will the votes count?

Well, that is what we are saying today that if we want this democracy to survive, don't play games with Edo's election because the moments are different. This is not a general election. It is a sole day election. So, everybody will be watching and looking. And if we need anything in Nigeria today, we need a smack of credibility. So, I don't believe people in Abuja are that dumb and crazy not to understand the danger and the crisis we will face if they don't allow the votes count and they want to militarize the election. And in any case, the feedback is why should they do it? It is not like I willingly left APC, right? APC donated Edo to PDP. Oshiomhole donated Edo to PDP. So, would they now come and fight and quarrel with us? No. They should rather fight with the man who decided to give away seven states.

You saw what they did in Imo and that of the Kogi. How prepared are you?

What I am saying is that as a governor of a state, it is not my style to begin to talk about violence and all of that. But, I want to say that they should be sensible not to try it because unlike other states Edo is in the middle of the country and any crisis in Edo today will have a major effect on other states in the country. And we are ready for it. Our style is not to propagate about it but they want to.

Before you left the APC, you visited President Muhammadu Buhari. What were your interactions with him?

I think for me everybody was shocked and even the president don't know they would do that. The President did not believe Oshiomole would do that. The President is not a man that talks much but expects everybody to be reasonable. Every time I have interaction with him, he says people should do their work. So, I am not sure he believes that they would have got to that extent. I am not surprised, therefore, that after I left those reactions followed.

Your opponents have been saying that you have nothing on ground, including your certificate. We would like you to

react to that?

I think it is about the press really because someone who comes out in Nigeria and tells a very obvious lie and you are listening and say okay. I mean, how can you even talk about my certificate when the university that issued it has come out itself to say that this person graduated this year and the person is saying he has issues with my certificate? So, what do you want me to do? He said I have done nothing and that there is nothing on ground. A few of you have come and you have seen what is on ground. But, they are saying nothing is on ground. All the teacher's union are saying well done for transforming education in Nigeria. But, they are saying we have done nothing. You see it is the old politics-just tell the lie tell the lie. But, this country is different now. It is about us getting stakeholders on the table. This democracy is now 21 years. A child that was born in 1995 is how old today? So, that old politics of just go and tell a lie and continue to repeat the lie in the age of technology is uncalled for.

I am sure a lot know the underlying changes that have occurred in Nigeria. People are not stupid and foolish. Eid-el-Kabir 2020 Amid COVID-19

F or the first time in living memory, the Muslim World is celebrating the very important festival of the ram, otherwise known as Eid-el-Kabir, in a very subdued way prompted by the Coronavirus pandemic. This fact, however, can only deepen the significance of the occasion rather than diminish it. Importantly, the festival remains a key reminder of God's mercy to mankind, and the need for people, especially Muslims, to devote their lives to serving God.

Given reports that the last global pandemic comparable to the Coronavirus happened perhaps more than 100 years ago, hardly is there anyone who can remember whether or not such pandemic adversely affected religious occasions such as Eid-el Kabir. This year, as it happened in the celebration of the Eid -el-Fitri two months ago, there will be no congregational prayers in many places. And where government permits such, it will be observed under strict rules and supervision contrary to the usual routine.

Significantly too, the performance of hajj, or the holy pilgrimage to Mecca in Saudi Arabia, which is a strong pillar of Islam, is conspicuously missing, again for the first time in human memory. The Coronavirus pandemic has foreclosed the desire of about two million prospective pilgrims that yearly perform the ritual, just before the Eid. It is understood that only about 1,000 pilgrims have been allowed for the hajj this year all over the world.

To many Muslims, the fact of COVID-19 should only add to the sobriety naturally required for the Eid, much against the looseness with which most Nigerians are given while devouring sallah meat. Many do not remember that but for the mercy of God in substituting Prophet Ibrahim's son with a ram at the point of sacrifice, Muslims would have been apprehensive of the occasion rather than look forward to it. No father will be excited to sacrifice his son, not even for God.

Prophet Ibrahim (May Allah's peace be upon him) certainly wasn't excited when he saw repeated visions of God asking him to sacrifice Ishmael to him. But he was prepared to totally obey his creator, and would have sacrificed the son if God had not shown his merciful disposition at the last minute, by providing a ram in place of Ishmael for the sacrifice. The Eid is a reminder to all human beings of God's infinite mercy, which has sustained human existence over the years.

The great lesson of the period therefore is to praise and supplicate God at all times for his mercy and blessings; and to reciprocate by worshipping him as the only person worthy of worship, as well as to obey all his commandments. Muslims are expected to manifest this injunction by freely felicitating with their neighbours and giving food and other forms of assistance to the less privileged.

Those who can afford to buy rams or cows in this austere time should remember to share it in accordance with Islamic dictates of allocating portions to the family, to friends and neighbours; and to the needy and the poor. This itself is in strong fulfilment of the purpose of having, which is to be able to give to those who lack.

Rather than engage in unbridled merriment, Muslims are enjoined to observe the Eid with utmost moderation and fear of Allah. This spirit, if truly embraced by both leaders and followers at all times, will provide an enduring foundation for national development of country and its people. The absence of the spirit of give-and-take in Nigeria, manifested in the preponderance of massive corruption ravaging the land, is largely responsible for the siege-like state of its existence.


It is a pity that for 10 years running, Nigerians have been embattled with the crisis of Boko Haram, banditry, senseless killings and destruction, as well as armed robbery and kidnapping. Yet every year, government allocates huge resources - human and financial - to check the vices; but due to the absence of sincerity and honesty, some people seem to thrive in making the impasse everlasting, not minding the great cost to human lives and properties.

Clearly, God has been faithful to mankind particularly to Nigerians, but Nigerian leaders have not been faithful to the masses, using them merely as pawns in political power play. Otherwise, there should be no place for the corruption being daily exposed, whereby leaders siphon or mismanage public funds meant to uplift millions of very poor, hungry and homeless citizens. Southern Kaduna: The Growing Evil Of Silence

"What is left of a country where women widely went naked, wailing for husbands and children because they are no more. Southern Kaduna cruel murder" – Olajuyigbe Gbenro

he above is culled from a Facebook post by a citizen whose regular catchy phrases; scathing depiction of the tragicomedy that has now become a peculiar feature of state of affairs in Nigeria I have come to admire in the last one month. My response to the said post triggered the title of this piece.

How Nigeria got to this sorry state is not an issue to warrant dissipation of energy as the Chicken has indeed come home to roost. But pretending that the prevailing evil of silence will not hurt sooner than later should however come across as deeply worrisome. Perhaps, to have imagined that a consistent pogrom will continue unabated for over three years in Southern Kaduna is to have prepared the minds of citizens for the eventuality of failure of leadership that now confounds.

Few days ago, chief of Army Staff, General Tukur Buratai alerted Nigerians and in clear terms as to where responsibility to protect lives and property now resides. How could we possibly have imagined that Nigerians will one day be confounded with the charge of having to live with the horror of armed attacks, banditry and terrorism until and unless the very victims of the assault are willing to put a stop the very evil that stares them in the face? How terrible can the audacity of failure pass across as refrain for denial! Where exactly do we go from here! There should no longer be pretense about the

egregious failure of leadership that looms large

if not already manifesting. The increasing fortresses of ungoverned spaces which are picturesque of a sinking sovereign State are all pointers to how the Nigerian state totters in the precipice.

The dreadful images of bloodletting from war-torn countries decades ago are now here with us on a daily basis. Curiously, statistics of horror in some countries contending with full scale civil war dwarfs the growing civilian fatalities from terrorism and banditry in Nigeria. Regrettably, we simply carry on as though nothing happens; so long the political elite entertain us with the buffoonery of their intra-class war which now finds some ready and plausible rationalizations in anti-corruption politics through which monumental sleaze is entrenched in greater momentum than hitherto seen or anticipated.

However, much more disturbing than the evil which defenseless Nigerians daily sleep with and wake up to in their communities is the growing evil of silence that has seized the society at an unusual time in history. Three months to 2019 presidential election, I had an impromptu engagement with a cab driver in Lagos who turned out to be well educated and enlightened but more importantly a concerned stakeholder in the seemingly intractable violent conflict in Southern Kaduna. He was initially taken aback by the curious attention I paid to a sticker of SOKAPU (Southern Kaduna Peoples Union) which adorned a rather conspicuous space below his car dashboard.

I was prompted by the sticker to begin a talk with him as soon as we began the intra-city trip. So you know about SOKAPU, he intoned. Yes, hope things are calming down over there now I responded. The grim details of the carnage and despair alluded to through the encounter left a huge picture in my mind regarding our collective failure to as citizens of supposed sane clime to call out those who cheapen our humanity through denial and if not implicit collaboration.

The level to which we have reduced humanism through conspiracy of silence can only pass across as horrendous considering the several incidences of bloodletting that have rendered communities across the country desolate. Sadly, these communities today remain as vulnerable to unmitigated attacks by marauders who seem to be perpetually at large even when the horror they wreck almost on daily basis reminds us of their terrifying presence.

The conspiracy of silence which inexorably boils down to reinforcing act of evil tells how much we have failed humanity in our immediate space within the sovereignty that binds us as a people. Yet, we pretend to be worthy partakers in the global voices for equity and justice. The looming culture of hypocrisy and denial should readily alert us to the sensibleness we took for granted in the days of military rule. For, in the obviously saner clime that Nigeria was in the dark days of the jackboots, we still managed to connect voices; even if muffled in denouncing evil and in condemning perpetrators and willing collaborators.

In spite of the throes we bore under unelected usurpers of instrument of governance, we were saner enough to demand responsibility and modicum of accountability from those who occupy seats of power. I recalled how popular voices picked holes in Ibrahim Babangida's description of Zango Kataf riot as "civilian equivalence of coup attempt" justifiably perceived as smokescreen for unleashing terror. We never invested iota of hope in the ability of military regime to live up to the responsibility of deploying instrument of the state to imbue stable polity, yet popular voices were influential enough to at least hold government accountable for the sake of humanity.

We now live in a new Nigeria where bereaved and desolate half-naked women of Southern Kaduna appear no longer worthy of empathy of their fellow citizens. We have been wired to accept vivid images of women and children mowed down in in cold-blood as just another passing phase for a country whose facile unity must endure at all cost and at whatever havoc wrecked on innocent citizens. We have been bruised and blackmailed to accept that raising a finger against the government of the day is akin to treason. Shockingly, the government appears now confortable with spewing extenuating circumstances that serve its penchant for denial and abdication of responsibility.

It would appear we have been coerced to accept that the government of the day owes us no responsibility to guarantee the security of lives and property as the first and most important condition for the legitimacy of authority the exercise over the rest of us citizens. Where exactly are we headed as people and as a country? What could be more disconcerting than the foretold warning handed down by a key official of government months ago to the effect that the choice to live or die is entirely that of the people to make if they dare assert legitimacy over their ancestral land. And as if messages which glaringly attest to official denials of responsibility are not sufficient and telling enough, it may as well be that we are just waking up to more startling realities of abdication of leadership as citizens' rights to security of lives and property may be reduced to petty buck-passing and intra-class accusations and counter accusations while cold-blooded murderers reign supreme in our midst in continuation of brazen impunity.

Between Community Policing And Restructuring

There are in the words of the sage, important limits to human relations, knowledge, awareness, and technological state, economic and financial resource availability, social and cultural exposures. Political and Socioeconomic problems which are the product of human actions and reactions are not static. They change with time and place. What is a social or political problem in one society may be a norm in another. And what is rejected or frowned at today may be accepted tomorrow.

But, often always, inability to manage such differences and changing times by nations has at different times and places led to obstacle in relationships; misconceptions on politics, security and economic issues. Corruption, insecurity, community policing and restructuring are some of the typical and topical political and socioeconomic problems that have in recent years dominated not just the public space but the nation's national discourse.

Take insecurity as an example, the nation is in dire state of strait. And as a response, individuals, groups have proffered solutions to the security threats in the country. Take as an illustration, while applauding the launch of the Western Nigeria Security Network (WNSN), codenamed Amotekun. An initiative of the Southwest governors-adjudged by well meaning Nigerians as a perfect way of bringing "policing arrangement close to the people in their various communities, the Social and Economic Justice Advocacy (SEJA)-a Lagos Based non-governmental group, a while ago, in conjunction with other prominent Nigerians, also called on President Muhammadu Buhari to create quasi-military outfits devoid of ethnic colourations. Noting that states should create their out security outfits but be supervised by the federal police. It should not be regional. If it becomes regional, you will begin to see ethnic and tribal colourations. The states should employ and fund it under the supervision of

the States Commissioner of police.

Such creations the group added should be given specific mandates to deal with criminal elements in the country. They should be equipped with communication tools while being supervised by the Nigerian Police Force. Again, industrialisation of the country will help to draw the youth out of criminal intentions,

The concern over security and effective policing recently resurfaced as the Deputy Inspector General of Police (DIG) in charge of South West Geo-political Zone, Leye Oyebade, during his familiarisation tour of Oyo State Police Command, recently, advised officers to key into the community policing initiative in order to reduce crime in the country. The DIG said that it was only community policing that would help to reduce crime to the barest minimum level in the country.

Perfectly a well structured position. The police Boss' position becomes even more appreciated when one remembers that he is not alone in this line of argument.

This admonition becomes even more appreciated when one remembers that bout two years ago, President Buhari while he played host to the traditional rulers from the Northern part of the country led by the Sultan of Sokoto, His Eminence, Alhaji Muhammadu Sa'ad Abubakar III, at the Presidential Villa, Abuja, Mr President going by reports stated that; the ongoing reform of the Police would include recruitment of more hands, cultivation of stronger local intelligence and networking with communities, traditional rulers and adequate training. This in specific terms he added will include recruiting more police officers from their local government areas, where they would then be stationed in the best traditions of policing worldwide. Working with the state governments; we intend to improve the equipping of the police force with advanced technology and equipment that can facilitate their work.

From the attributes of his speech, he did not only underline the importance of such arrangement but underscores the virtues and advantages of recruiting more police officers from their local government areas, where they would then be stationed in the best traditions of policing worldwide.

Precisely, this form of security architecture and community policing was amazingly the part of what the pro-state police and nations' restructuring advocates demanded for –particularly as it was obvious that the vast majority of states can afford to equip their officers with the sophisticated security gadgets Mr. President listed above.

"We can restructure within one Nigeria context." Governor Abdullahi Ganduje of Kano State does not favour restructuring as "panacea to the nation's current socio-economic woes"; rather he prefers restructuring of "the national mindsets" aimed at returning Nigeria to "the path of progress."

In view of the above, I am tempted to ask; why can't the Federal Government allow and support the creation of state police where the state Commissioner of Police will be answerable to the state governor.

To further support the argument, if objective analysis can replace emotional discussion regarding state police/restructuring, one thing will definitely stand out; Nigeria has a choice, to restructure by plan or by default. As has been argued at different times and places, a planned restructuring will be collaborative, systematic, and redesign Nigeria, yet keep it whole while a default restructuring will on its parts happen, certainly not by choice, but definitely like an uncontrolled experiment with attendant risks and indefinite outcomes.

To further arrive at the answer, there are in my views, no federal police or state police models, but there are fundamental differences between the two. While cultural and geographical homogeneity which are strong factors and advantages of state policing are lost in federal policing, state police depend on these factors and more such as historical and friendship to keep the society orderly and without anarchy. This values no doubt makes a productive policing without disorder. And it is my belief that state governments have the capacity to fulfil this obligation.

Separate from the above position, there is no alternative to having the country restructured. The reasons are not far-fetched.

First, President Buhari in his campaign in 2015, promised to "Initiate action to amend the Nigerian Constitution with a view to devolving powers, duties, and responsibilities to states in order to entrench true Federalism and the Federal spirit.".

To further refresh our minds on this topic, what the masses are saying and wanting in my understanding is that the padding of the second schedule of the exclusive legislative list, of our 1999 constitution with sixty-eight (68) items has made Abuja suffer 'political obesity' and need to shed some weight via power devolution.

What the people are saying is that the over blotted exclusive list has made our nation to currently stand in an inverted pyramid shape with more power concentrated at the top and the base not formidable enough making collapse inevitable if urgent and fundamental steps are not taken.

What the proponents of restructuring are saying is that majority of the items are too trivial for the Federal Government to handle and should serve the greater good of the people if left in the hands of both the state and the local government. This is the hub of the masses expectation.

Items such as; Police and some government security services, mines and minerals; including oil fields, oil mining geological surveys, control of parks, stamp duties, public holidays, taxation of incomes, profits and capital gains, and insurance among others to my mind should find their ways back to the states and the local councils.

Restructuring the nation will no doubt take care of community policing.

NCC Gives Reasons For Revising Complaint Categories, Service Level Agreements

ne Nigerian Communications Com-(NCC) mission said it undertook a revision of the framework stipulating the processes for resolving consumer complaints arising from service delivery by telecoms operator in order to achieve greater effectiveness in the sector and to strengthen protection of telecoms consumers and other stakeholders.

Tagged: 'Complaints Categories and Service Level Agreements (CC/SLA)', the framework was revised by the Commission in November.

2019 at a programme attended by representatives of telecoms operators, consumers and other consumer rights advocacy groups in the country.

"The 2019 review of the CC/SLA, in collaboration with operators and other stakeholders, was essentially to strengthen effective and prompt resolutions of consumers complaints by reviewing the timelines, broaden and streamline complaint categories and establishing applicable sanctions on operators that fail to meet the timelines stated for resolving

If the matter is escalated to the Commission, the consumer is expected to receive a feedback within two hours, while the Commission ensures the issue is resolved within 48 hours. Additionally, the subscriber shall be offered an apology, and the expiry date of his data bundle shall be extended by the number of days the disruption lasted.

Under the broad category, 'Billing', complaints connected to any unexplained change in account balance resulting in a drop in balance, due to overcharging subscriber's account for calls, Short Messaging Services (SMS) and Multimedia Messaging Service (MMS), shall be resolved by the operator within 24 hours.

Also, under the new CC/SLAs that have now come into force, in the case of Sales Promotion and Advertisement, when a subscriber does not receive (within stipulated

time) bonus or incentives won during promotions, the service provider shall resolve the matter within 12 hours of receiving the complaints, instead of 24 hours as stipulated in the hitherto existing categorisation and agreement.

Similarly, in the expansive category of Call Centre/Customer Care, the NCC agreed with stakeholders that when a subscriber is unable to connect to Call Center or Service Provider Help Line, the matter shall be treated by the Service Provider within four hours of receiving the report.

On matters connected to

faulty terminals, such as defective devices that stifle a subscriber's ability to use phones, modems, routers and related devices appropriately, the Commission said such incidents shall be resolved based on Terms and Conditions for all devices.

The EVC added that the CC/SLA document, which is available on the Commission's website, contains 17 broad categories and about 90 subcategories. He enjoined all stakeholders, particularly the telecom consumers, to create the time to study the document in order to understand their rights and privileges.

country's government said recently it seeks to unify the rates in a year, coupled with the aftermath effect of the global COVID-19 pandemic, the extent to which the falling value of the country's currency will affect the telecom sector may still be too early to determine.

Glo Delights Customers With More Data

Globacom has announced an immediate increment in the volume of data for its subscribers buying or renewing Glo data bundles. The operator in a press

statement,said extra data will now be available to all its subscribers who purchase any of its data plans.

The statement said any new customer who purchases a daily data plan of N50 will get additional data value of 18MB making a total of 50MB as against the former data value of 32MB. The bonus includes 5MB of data useable at night between the hours of 12 midnight and 5am.

Any Glo subscriber, who purchases a daily data plan of N100 will now get 150MB which will include 35mb of night data value. In the same vein, subscribers who go for the N500 data plan valid for 14 days will now get 1.35 GB of data instead of the 1GB they used to receive up till now.

A night time bonus of 550MB is part of the new package.

Subscribers who go for the N1. 000 monthly data plan will receive a whopping 2.9 GB inclusive of 1 GB of data useable only at night. There are other data bundle options up to N20, 000. For instance, 12GB of data has been added to the N20, 000, bringing the total to 138GB instead of the erstwhile 115GB.

The company stated that its data offers are currently the best at the market both in terms of the price points and the quality of the data service.

Nigeria Data Protection **Regulation Act 2019 Impacts COVID-19** Contact Tracing

The Nigeria Data Protec-tion Regulation (NDPR) Act 2019 is an important regulation that protects the security and privacy of a living Nigerian national individual personal data.

Personal data within the regulation refers to any data that can identify a living person such as name, picture, video, email, address and others.

The regulation further defines a subset of personal data such as health data that will impact the individual greatly if exposed, thus more due care should be taken with these subsets of personal data called sensitive personal data.

The Nigerian government have adopted the contact tracing approach to reduce the spread of COVID-19.

Contact tracing is the process of identifying, assessing, and managing people who have been exposed to COVID-19 to prevent onward transmission. When systematically applied, contact tracing will break the chains of transmission of COVID-19 and is an essential public health tool for controlling the virus.

Contact tracing for COVID-19 requires identifying people who may have been exposed to COVID-19 and following them up daily for 14 days from the last point of exposure.

The processing personal data for COVID-19 contact tracing is lawful under the Nigeria Data Protection Regulation since it is being carried out for public interest, however the principles of processing personal data still needs to adhered to.

In utilising contact tracing the government need to perform the below due diligence, to ensure the principles of processing personal data under the Nigeria Data Protection Regulation Act 2019 is adhered to:-

Adequacy

During contact tracing only ask people for the specific information that is needed. This may include things like their name, contact details and time of arrival for example.

Transparent

During contact tracing be clear, open and honest with people about what you are doing with their personal data. Tell them why you need it and what you'll do with it.

Secure the data collected

During contact tracing you must look after the personal data you collect. That means keeping it secure on a device if you're collecting the records digitally or, for paper records, keeping the information locked away.

Do not use it for other purposes

You cannot use the personal information that you collect for contact tracing for other purposes, such as direct marketing, profiling or data analytics.

Data retention

You should not keep the personal data for longer than needed. It's important that you dispose of the data securely to reduce the risk of someone else accessing the data. Shred paper documents and permanently delete digital files from your recycle bin or back-up cloud storage, for example.

Economy

According to the National Bureau of Statistics, a total of NGN651.80 billion was generated as Value Added Tax (VAT) in H1-20. Relative to the same period from a year ago, the achieved VAT is 8.5% higher. However, at this run-rate, total VAT receipts are trailing the FGN's 2020 budget. For better context, at NGN651.8 billion over H1-20, the reported VAT is 36% lower relative to the FGN half-year target of NGN1.02 trillion in the revised 2020 budget. Meanwhile, on a quarterly breakdown, VAT receipts in Q2-20 grew marginally by 0.81% q/q to NGN327.10 billion (Q1-20: NGN324.60 billion), benefitting from the implementation of the VAT hike in February 2020, even as the COVID-19 pandemic disrupted economic activities in the period. Notably, collection rates were lower across key sectors such as Federal Ministries & Parastatals (-22.90% y/y), Building and Construction (-2.21% y/y), and Offshore Operations (-9.37% y/y). On our estimate, the FGN will face the hurdle of generating c. NGN689 billion per quarter to, at least, meet its 2020 target. The foregoing is a tall order in our view, given the low level of activities from the onset of the COVID-19 outbreak, together with the COVID relief packages for small businesses which includes VAT exemptions.

The Budget Office recently released the 2021-2023 Medium Term Expenditure Framework (MTEF) which we understand is in line with the provisions of the Fiscal Responsibility Act (FRA) 2007, a guide for the policy thrust behind the public finances of the FGN. In the document, the Nigerian economy is forecasted to contract by 4.2% y/y in 2020 (Cordros estimate: -3.4%) on the expectation that oil GDP will contract by 12.96% y/y, together with a slower contraction in non-oil GDP growth (-3.6% y/y). Beyond 2020, the economy is expected to gradually recover with GDP expected to grow by



3.0% y/y, 4.7% y/y, and 3.9% y/y, in 2021, 2022, and 2023, respectively. Oil revenue was also forecast to grow by c. 96% in 2021 (2020 estimate: NGN1.01 trillion) on oil production assumption of 1.86mb/d and an average oil price of USD42.00/barrel. Overall, the aggregate FGN revenue for 2021 is projected at NGN7.50 billion, while aggregate expenditure is estimated to be NGN12.66 trillion (2020 revised budget estimate: NGN10.81 trillion), leading to a fiscal deficit of NGN5.16 trillion. On a percentage of GDP basis, the expected deficit is 3.63% of GDP, which is well above the 3% limit set by the FRA 2007. In our view, until the FGN implements strategies to unlock new revenue sources, we believe it will not be feasible to keep the deficits within the 3% target.

Capital markets Equities

With negative expectations already priced in, earnings did better than expected, spurring investor interest across Cement and Tier I bank stocks and driving the market to a positive close (+0.9%) for the month of July. For the holiday-shortened trading week, the All-Share index rose 1.1% WTD to 24,693.73 points, closing in the green in 2 of 3 trading sessions, and reducing the YTD loss to -8.0%. On sectors, the Industrial Goods (+3.6%) index sustained last week's gains, with the Banking (+3.0%) index joining the leaders' list. Conversely, the Oil & Gas (-6.5%) and Consumer Goods (-0.4%) indices closed in the red. The Insurance index was flat.

Our view continues to favour cautious trading as risks remain on the horizon due to a combination of the increasing number of COVID-19 cases in Nigeria and weak economic conditions. Thus, we continue to advise investors to seek trading opportunities in only fundamentally justified stocks.



Trading in the Treasury bills secondary market was bullish, on the back of the still buoyant system liquidity. Thus, the average yield across all instruments contracted by 29bps to 3.5%. Across the segments, average yield at the OMO segment contracted by 41bps to 4.2% whereas they expanded slightly by 1bp to 1.7% at the NTB segment, as market participants shifted focus to this week's PMA. At the PMA, the CBN offered to investors maturing bills worth NGN265.95 billion. The auction closed with the CBN rolling over NGN49.84 billion of the 91-day, NGN54.59 billion of the 182-day and NGN161.52 billion of the 364-day – at respective stop rates of 1.20% (previously 1.30%), 1.50% (previously 1.80%), and 3.40% (previously 3.35%).

For next week, the tight liquidity expected in the system should cause reduced demand for instruments in the space.


The Treasury bonds secondary market continued to trade with bullish sentiments, as the healthy liquidity in the system sustained local participation, and as investors reinvested coupon payments. Consequently, average yield contracted by 20bps to 7.1%. Across the curve, yield contracted at the short (-30bps) and mid (-44bps) segments, as investors demanded the MAR-2024 (-66bps) and MAR-2027 (-125bps) bonds, respectively, while they expanded at the long (+6bps) end, following sell-off of the JUL-2034 (+31bps) bond.


We expect investors to continue to cherry-pick attractive yields, notwithstanding the expected strain in system liquidity.


Foreign Exchange

The CBN's foreign reserves sustained its descent as FX outflows continue to outpace inflows, thus dipping by USD59.86 million w/w to USD35.92 billion. Consequently, the naira appreciated marginally against the US dollar by 0.06% w/w to NGN389.25/USD at the I&E window but weakened by 0.7% to NGN475.00/USD at the parallel market. In the forwards market, the naira appreciated against the US dollar across the 1-month (+0.2% to NGN390.47/USD), 3-month (+0.4% to NGN393.45/USD), 6-month (+0.4% to NGN398.7/USD) and 1-year (+1.5% to NGN412/USD) contracts.

Despite the CBN's stronger commitment towards exchange rate unification, we still see legroom for the currency to depreciate further, at least towards its REER derived fair value. Our prognosis is hinged on (1) the widening current account (CA) position, (2) currency mispricing, which could induce speculative attacks on the naira, and (3) the resumption of FX sales to the BDC segment of the market which should place an additional layer of pressure on the reserves as the CBN funds the backlog of unmet FX demand.

NAICOM, Shippers Council Propose Inter-Agency C'ttee To Ease Cost Of Doing Business At Seaports

he National Insurance Commission (NAICOM), in its bid to deepen insurance penetration, has proposed an interagency committee with the Nigerian Shippers Council (NSC) on how best to collaborate in the development of maritime and insurance sectors.

The collaboration, according to NAICOM, would see the two agencies work together to introduce insurance cover for containers at both inside and outside the seaports and in addition reduce the cost of doing business at the nation's seaports.

Mr Olorundare Thomas, Commissioner for Insurance, who disclosed the development in Abuja when the Council's delegation visited the management of NAICOM expressed willingness to collaborate with NSC to make insurance significant in the maritime sector.

Thomas commended the NSC for bringing up creative ideas that would deepen the market of the Commission in the maritime industry

"As far as I can remember, this will mark one of the few times that any of

Hassan Bello, Executive Secretary of NSC, responding explained that the two agencies would also look into risk management at the various Ports to ease business.

According to Bello, insurance

should be viewed from various areas of policies involving goods on transit, accidents, loss, damages in order to move away from religious sentiments that everything happened for a reason.

He explained that containers deposit at the ports is about N150,000 to N200,000 on each container which runs into billions of Naira thereby making supply costly.

Explaining further, Bello said this was because most of the containers could not be returned within the expected date due to the nature of the roads.

"As part of our functions as ports regulator, we have our eyes on the cost of doing business in Nigeria. So, in the ease of doing business and the cost of doing business, we want to make our ports competitive, we have to moderate the cost.

'One of the costs is Insurance deposits that shippers pay for taking the containers out of the port.

"The containers are the assets of the shipping companies, they must be returned in perfect condition. If the containers are not returned, the deposit is not refunded.

"When you return the contain-ers in good time, you collect your deposit back.

'However, that is not as simple as that, access to the port maybe difficult and if a container is not returned within a certain time limit, they could be a problem, one loses his deposit or part of the deposit and so the shippers have to forgo the deposit.

"Sometimes the shipping company, even when the containers are returned they don't pay the deposit in good time and that is money lost.

'So what we are saying is, there are lot of issues like that, that we could have the insurance company come to take care of," Bello said.

He said that the insurance company could come in to make sure the containers are covered at a lesser cost, to reduce some of the challenges faced by the shippers.

He said: "We want policy on the participation of insurance in container regime, there is policy on goods in transit of course, and we want the policies to cover most of the risk that shippers, freight forwarders incurred including demurrage and rent.

The Federal Government has set a target to achieve 25,000 to 30,000 Megawatts of electricity. How feasible is this target?

President Buhari's vision for 24/7 power supply in Nigeria, has culminated in the inauguration of the 'Presidential Power Initiative Project (PPI). PPI which is a power infrastructure upgrade and modernisation programme agreed to by the Nigerian Government and Siemens A.G. of Germany, with the support of the German Government.

Nigeria and electricity giant, Siemens, have signed a power deal that will lead to the production of 25,000 megawatts of electricity by 2025.

The total costs of the project which covers some states of the Federation sum up to N5.1 trillion.

To kick start the pre-engineering and concession financing for the project, President Buhari has approved the release of funding for the first part of phase 1 of the PPI.

Likewise, works have started on the Mambilla hydro- electric power station with a capacity for providing 3,050 megawatts of power into the national grid when fully on stream.

When completed the hydro -electric power station will be the largest power generation installation in the country, and one of the largest hydro- electric power stations in Africa. At the cost of \$5.8billion to the public purse in Nigeria, the hydro-electric project in comparison with the gas-fired power generation plants, offers good value for money.

The embedded power generation rescue measure emerged from the decision by the Federal Government to end the traditional ring fencing privileges enjoyed by the existing 10 GENCOs, and thus removes the restriction for generation of electricity to enable state governments and other private investors to engage in power generation, transmission and distribution on localised basis, invariably without recourse to the national grid.

How do you think nuclear power can boost these efforts?

Nuclear is important to sustainable energy mix and is the second largest source of low carbon electricity, after hydropower and because it can be relied on all year round, irrespective of whether the wind is blowing and the sun is shining, it surpasses the hydro electric power on grounds of being 100% reliable for generating power allround the year.

The time is right for small modular nuclear reactors. Policymakers, the environmental community, and electricity providers are agreeing that nuclear power belongs in the mix to meet future clean energy objectives.

Are there countries using this source of power?

Twelve countries in 2018 produced at least one-quarter of their electricity from nuclear. France gets around three-quarters of its electricity from nuclear energy; Hungary, Slovakia and Ukraine get more than half from nuclear, whilst Belgium, Sweden, Slovenia, Bulgaria, Switzerland, Finland and Czech Republic get one-third or more.

South Korea normally gets more than 30 per cent of its electricity from nuclear, while in the USA, UK, Spain, Romania and Russia about onefifth of electricity is from nuclear.

Japan is used to relying on nuclear power for more than one-quarter of its electricity and is expected to return to somewhere near that level. The relative advantages of nuclear power stations over other sources of power supply in

Nigeria are as follows: Nuclear power stations do not burn fossil fuels to produce electricity and consequently they do

not produce damaging, polluting gases. Many supporters of nuclear power production say that this type of power is environmentally friendly and clean. In a world that faces global warming they suggest that increasing the use of nuclear power is the only way of protecting the environment and preventing catastrophic climate change.

In Nigeria, virtually all the existing thermal power stations relying on gas for power generation have not been operating in their full capacity largely because of disruption in gas supply caused by pipeline vandalism in the Niger Delta Region. Likewise, the hydroelectric power stations are

Sharing the UK Government Experience: In just a few years - during the early 2020s - many of the UK's power stations are expected to close. If they are not replaced, there might not be enough electricity supply to meet the demands of houses and businesses.

Nuclear is a vital part of UK Government energy mix. The UK Government has provided up to £56m of funding for research and development in mini-nuclear plants.

The funding will be available over the next three years and will be used to assess the potential of designs of advanced and small modular reactors (SMRs) and accelerating their development,

Small Modular Reactors (SMRs) could unlock new generation and economic growth.

It is high time our Policy makers, decision takers and the entire populace in Nigeria realised that nuclear power is the only source to meet future clean energy objectives of Nigeria and the rest of Africa.

Nigeria must show the way as the Big Brother of the African Continent. Nigeria is the country that can provide the catalyst for this positive

change in Africa.

And it will portray Nigeria as the African continent country example of leadership in green energy.

Above all, it remains very crucial that a factual public awareness campaign gains greater momentum. Nuclear is still the most viable option in order to stimulate the economy, despite public sentiments often being negative.

Tell us the role embedded power will play?

The embedded power projects embarked upon by the state governments is designed to stimulate private sector investment in the development of electric power generation and distribution in the state.

Under this embedded power scheme, the private operators will be able operate mini-grids to cover the localised target communities.

How much efforts have you seen in the area of energy mix by this administration?

For a long time, policy makers and decision takers in Nigeria have neglected the consideration of a comprehensive sustainable energy mix and thus, they have failed to explore very vigorously the full power supply resources.

However, their perceptions are changing gradually with some focus now on renewable energy sources including solar panels, wind, tide, and waste-to-energy projects.

Whereas, Nigeria need a more diverse and balanced energy mix, Nuclear is a vital part of our energy mix, providing low carbon power now and into the future.

As we are all aware, the world is moving towards low carbon energy which justifies the increasing need to consider the nuclear power plants as suitable sustainable energy mix.

Very astonishingly, the Federal Government has responded very poorly to our proposal to set up small and modular reactor nuclear plants in remote locations to drive industries and mineral mining activities in the country.

Our investors are ready, willing, and financially capable to establish the nuclear power plants on condition that the Federal Government issues Sovereign Guarantees 'SG' against political risks in favour of the foreign investors.

Unfortunately, the policy makers and decision takers are unwittingly reluctant to promote the nuclear power generation in the country on grounds of their unsubstantiated fears of nuclear accidents and radiation release which have since been overcome by advanced development in technology and engineering design.

When it comes to hydro, Nigeria also has vast untapped potential.

The Federal Government has committed to completing hydro power projects including the 3,050 megawatts Mambilla project, 700-megawatts Zungeru and 30-megawatts Gurara.

There are numerous smaller hydro projects lying idle including Ikere Gorge dam, Oyan dam, Bakalori dam, Tiga dam, Challawa dam and Dowa dam, and all have huge hydro power potential.

Revamping these abandoned dams around the country will deliver close to 500-megawatts of hydro power which can serve about 700,000 people.

Some investments are currently ongoing in mini-grid space. Do you think this can stimulate generation efforts.?

Our existing on-grid power statistics is surprisingly poor with almost 200 million people.

To put that in perspective, the small Caribbean twin islands nation of Trinidad and Tobago has 2,200 megawatts on their national grid for a population of 1.50 million people, equivalent to just one LGA in Lagos State.

While the problems continue to mount for Nigeria's on-grid power sector, opportunities are on the rise for companies operating in the country's mini-grid and off-grid power sector. Backed by a sound regulatory environment, strong government support from the centre, and increasing capital from investors and donors, the off-grid and/or mini-grid energy sector is fast emerging as one of Nigeria's most exciting new sectors.

With over 90 million Nigerians off the grid and another 50 million with less than six hours a day of grid power, the opportunity is enormous.

Currently, only one off-grid Company in Nigeria is a household name – LUMOS.

However, there are many more coming up behind them ranging from solar home systems to larger standalone systems to mini-grid to independent power projects (IPPs).

The Rural Electricity Agency (REA) is currently implementing multiple off-grid electrification programmes with the support of the World Bank, African Development Bank (AfDB) and the private sector, mostly through the deployment of solar power to electrify homes, communities and businesses.

The following programmes are currently being implemented: Energising Economies Initiative (EEI). This programme has been developed to support the deployment of clean and sustainable off-grid electricity solutions to economic clusters in Nigeria.

The aim of the EEI is to provide sustainable and affordable power to 1 million SMEs.

Under this EEI, the Federal Government has commissioned 3 markets across the Nigeria. Namely are, Sura market in Lagos, Ariaria in

Aba and Sabon Gari in Kano.

Energising Education Programme (EEP). The EEP is expected to provide adequate power supply of 90 MW in total to 37 Federal Universities and 7 University Teaching Hospitals across Nigeria.

AbujaBusiness How New Stamp Regime Will Affect Tenancy In Abuja, Suburb – FIRS Boss

gainst fears in Abuja of possible rent increase on account of the new stamp duties on tenancy across the country, Federal Inland Revenue Service (FIRS) has come to explain that cost of Rentage won't change much.

Explaining this, Mohammed Nami, Executive Chairman, FIRS, said that monthly or annual tenancy attracts a paltry 6 percent of the total sum.

"Again, for purpose of clarity, the 6% stamp duty rate is not chargeable across board. It is only chargeable on rent or lease agreement of above 21 years. If your rent or lease is between 7 and 21 years, the stamp duty rate is 3%. And if you pay your rent monthly or yearly, that is less than 7 years; your stamp duty rate is 0.78%. The 0.78% is the rate for most tenants like you and I who live in Suleja or Minna. If your rent is N100, 000 like you said, you only pay 0.78%, which is marginal. Of course those who live in Maitama who pay N10 million as rent will pay more at the same 0.78% because their rent is higher than our own in other parts of Abuja.'

Mr. Nami allayed the fear that stamp duty would lead to rent increase, saying: "Stamp duty should not make any landlord to increase his or her rent because it is not paid by the landlord. Landlords are not our collecting agents. It is the responsibility of the tenant to pay stamp duty and you don't have to give it to your landlord".

"As a tenant, calculate 0.78% of your rent and pay that fraction at the FIRS office nearer to you or at your bank. You should then fix the stamp duty imprimatur on the ten-



ancy agreement before you sign it with your landlord. It is as simple as that." he said.

He has assured tenants across the country that the Service is working on a stamp duty palliative package for them in view of the current economic realities occasioned by COVID-19.

Mr. Nami dropped this hint on Monday during a live appearance on the popular morning show, "Your View", on TV Continental (TVC) via video link, according to a statement by Director, Communications and Liaison Department, FIRS, Abdullahi Ismaila Ahmad. As part of the palliatives, the Executive Chairman hinted that stamp duty will not be collected in arrears from tenants, even as he told his interviewers that "there is never a time when taxation is convenient for everybody to pay" and enjoined Nigerians to embrace tax payment "as a patriotic duty to our dear country, Nigeria."

The Executive Chairman stated that the FIRS was aware that many taxable Nigerians and businesses in the country were going through difficulties imposed on all of us by COVID-19, hence the FIRS has consistently rolled out tax-related palliatives to relieve them of their tax liabilities since the pandemic shut down the Nigerian and global economy.

Nami stressed that contrary to some false claims in certain quarters, stamp duty was not a creation of the current administration of President Muhammadu Buhari or the current leadership of the FIRS.

He said: "Stamp Duty dates back to colonial times in Nigeria. It has been a form of tax in Nigeria as far back as 1939 when you and I were not yet born. It was codified in our laws in 1953; that is before independence. It was consolidated in 2002, published in 2006 and further reworked into the Stamp Duty Act 2004."

He continued: "The Joint Tax Board (JTB) where states are represented consider it necessary to bring the stamp duty act to the attention of Nigerians following the recent launch of the Inter-Ministerial Committee on Audit and Recovery of Back Years Stamp Duties where the new FIRS Adhesive Stamp Duty was unveiled. As chairman of the JTB, the FIRS was mandated to enlighten Nigerians on stamp duty. That's why the FIRS published a clarification notice on the stamp duty and we shall continue to educate the public on it.

Recall that at the weekend, Coordinating Director, Tax Operations Group, FIRS, Mr. Femi Oluwaniyi, stated that "the FIRS stamp duty on rent or lease only applies to new agreements and not to renewals. If a new agreement is drawn up at renewal, that document should be stamped, just like initial agreement. If, however, the renewal terms are already in the initial agreement such that no new document is prepared but just payment of the rent for renewal, then no stamping is required."

Dignity Finance Posts Impressive Dividend Despite COVID-19

Federal Government has explained reasons why it lifted the ban placed on a private airline, Executive Air Services Limited, which flew musician, Azeez Fashola aka Naira Marley, to Abuja to attend a concert mid-June, saying the airline has complained with conditions given.

It would be recalled that the airline had contravened the restriction placed on interstate movement and closure of airports in existence at the time.

Giving an update on the development during a Presidential Task Force briefing on COVID-19 in Abuja, Hadi Sirika, Minister of Aviation, said, "We lifted the ban on Executive Air Services Limited because they have complied substantially with all of our imposed sanctions; they've paid part of the fines, and they brought up premium plan. So, we have lifted the ban today, so, they continue to do their business.

"These sanctions are not punitive, they are things to make our industry work better and keep all of you safe."

In the same development the Presidential Task Force on COVID-19 said that government was working tirelessly to establish the protocols that would guide the resumption of international air travels, especially as it relates to arrivals into the country.

Boss Mustapha, Chairman of the Task Force, who disclosed this earlier in the week at a media briefing, said all relevant Ministries, Departments and Agencies (MDAs) were collaborating to achieve this, bearing in mind the importance of international air travels to the economic development of the nation.

James Odaudu, Director, Public Affairs, Ministry of Aviation, made this known in a statement made available to newsmen in Abuja.

According to the statement, Hadi Sirika, Aviation Minister disclosed that a National Air Facilitation Committee has been established to work out the modalities for a safe resumption of international flight operations in the country. Federal Airports Authority of Nigeria (FAAN), Nigeria Custom Service (NCS), Nigerian Immigration Service (NIS), Airline Operators of Nigeria (AON), Nigerian Civil Aviation Authority (NCAA), Nigerian Airspace Management Agency (NAMA), Airport Security Committee, Ground Handlers Association, Directorate of State Security Service (DSS), Freight forwarders association, the Nigeria Civil Aviation Committee and the Quarantine service.

The Minister, who lamented that aviation was one of the worst hit by COVID-19 pandemic, however noted that a quick lifting of ban of international travel without adhering to the laid down protocols would amount to disaster.

He also bemoaned the harrowing experience and downturn in the economy of Nigeria and by extension, its impact on aviation which has made it extremely difficult for many organizations to pay salaries.

FCTA Says Land Grabbers Hurting Estate, Property Business In Abuja

The Federal Captial Territory Administration (FCTA) has stated that land grabbers hurting estate, property business in Abuja, and therefore, vowed to prosecute culprits.

Speaking on behalf of the administration, the Director Department of Development Control, Murkta Galadima made this known on Monday, after the pulling down illegal structures built in Lugbe, phase 5 of the Federal Captial City, (FCC).

He said the administration was going to prosecute anyone found developing a plot without valid prove of ownership.

According to him; "This is a product of land grabbing. An individual claiming to own about 149 plots fenced it, and then combines it as an estate, called Seaman. They commenced development without even valid title or approved plan; they come to site, mobilise people and begin development. "Two weeks ago, we came and point the structures for them to remove but they failed to obey the order, and they still went on building that is why we are enforcing the action. We came this morning to clear the illegal structures.

"We removed some, but in the process they incited people within the area to stop the exercise, we are going to restrategise and return for the exercise" he explained.

He further stated that, those behind the illegal development are not known but the department would continue to resist the illegality.

"We are going to show the erring developers that there is law and government despite their resistance we will stop them"

The Director described residents that build without legal approval by the Department of Development Control as land grabbers.

He said the department was planning Lugbe to be in conformity with the master plan of the Federal Captial City (FCC).

Why Unemployment Remains Heart Of Long-Term Consumer Change – Report

wo important narratives have been conflated as the novel coronavirus (COVID-19) made its way around the world this year: the devastating impact of the deadly disease on the lives of millions and their loved ones and the almost immediate effect on the global economy.

The Fast-Moving Consumer Goods (FMCG) industry experienced significant and prolonged lifts in sales across most categories as COVID-19 spread and drove people into weeks of lockdown.

Their lives quickly centered on the home and the so-called "homebody economy" was born.

Sales across many categories that fed this trend remain stronger than in pre-COVID conditions- we're eating more meals at home, spending more time in our homes and consequently, everything from paper towels to garbage bags and cleaners are in high demand.

But as countries reopen businesses, even as total global infection rates soar, the two narratives will inevitably diverge.

The global economy and the behaviours of consumers within it face escalating levels of change, though the value and volume of growth was inevitable for many fast moving consumer group categories during lockdown conditions that may not be sustainable as economic challenges overtake health concerns.

Unemployment will be a significant driver of this change. For some consumers, furloughs will turn into unemployment; for others, particularly in developing countries with informal labour markets, reliable employment may remain out of reach for years.

The Organisation for Economic Co-operation and Development (OECD) expects

uncertainty on this front for years.

This week, it offered two projections for the U.K.: If there is only one wave of the virus, the OECD projects that employment in the U.K. will fall by 4.6% in 2020 and grow by only 2.1% in 2021 This would push overall unemployment to a record high of 11.7% by the end of this year.

Projections like these clearly highlight that consumers will need to recalibrate their spending habits.

In other words, we may still be eating more meals in our homes, but what we eat and how much we're able to afford will change, and that change may last years. And it won't just be food. Consumers will completely reassess what goes in their shopping basket.

As jobs dry up and young people are forced to stay at home with their parents for years longer than planned, the household shopping dynamic will change. We'll see millions of new multi-generational households. People will delay marriages and having children.

In short, life will get pushed back. And so will purchases. Consumers will buy their first big-ticket items like homes, cars, even appliances, later in life.

Earlier this year, as the full impact of COVID-19 was taking hold; the Nielsen Intelligence Unit identified a rapid reshaping of consumer spending dynamics. Put simply, the polarised spending environment will include "constrained" and "insulated" spenders, each of whom will spend according to their specific scenarios.

In the early days of the pandemic, constrained spenders were newly unemployed, such as travel and hospitality workers. Insulated spenders were often retired or working in corporate roles while shifting to working from home as global movement restrictions came into play.

But as we look down a clear path of

long-term economic recession, the meaning of polarised spending is shifting. For example, insulated spenders may tighten their belts to be fiscal practical to weather the uncertain times ahead.

The COVID-19 pandemic is forcing a global recalibration of priorities for countries, businesses, and individuals. For many consumers, it will mean an ongoing recalibration of lifestyles and meaningful changes in what they expect from brands and the retailers selling them.

And that means brands and retailers will need to serve consumers differently and in the context of low confidence levels for economic recovery.

Consider the likely shift toward demand for more value for money products. On the one hand, large multi-packs may offer the best value, but they may be out of reach for people short on cash.

Cash-strapped consumers may be forced to buy smaller pack sizes, and brand loyalty across categories may fade.

Consequently, FMCG manufacturers are reassessing their portfolios to adjust. Similarly, retailers are reconsidering how to stay relevant to consumers who will have rapidly changing consideration sets.

In the past, they could have performed these kinds of assessments with relatively ample time for testing. That is no longer the case. Changing retail channels are a case in point. Online adoption has taken just weeks to get to a tipping point that would have otherwise taken years. The U.S. offers a case in point with a 4% bump.

Whatever the channel, getting assortment and pricing right will be key. So, too will packaging and brand claims. Consumers are looking for clear claims that highlight the benefit of the product. Not surprisingly, there is strong demand at all price points for products offering and health benefits, such as immunity boosting capabilities or germ-killing powers.

The plan, which is another move by the company to give its customers a unique calling experience, is also expected to help cushion the effect of the global pandemic, Covid-19.

According to a Globacom statement in Lagos, subscribers who opt for the plan will be charged an access fee of N7, which will be billed alongside their first call of the day, after which they will be able to make calls to all networks in Nigeria at 11 kobo per second (exclusive of tax) for the rest of the day.

It stated further that the access fee of N7 will be waived for any customer who does not make any call but only receives calls throughout the day.

'Yes, 14 people were killed and about six others were fatally injured. The saddening thing is that out of the 14 dead bodies that were brought out, 13 were from one family.

"In that family, it is only one person that survived. His uncle, his mother, his uncle's wife, his younger brother, his senior brother's wife, his wife and all his children were killed, he said.

The commissioner said that the police had carried out some preliminary investigations and discovered that there had been fued in the community.

"What I think is, there has been a long-standing communal problem around that area which we are not clearly seeing, but we know that it would not be far from it.

"Presently investigation is in progress. The only person that survived the attack is already with us and he is helping us, the chief of that place is also helping us and some other (good) spirited individuals.

"The Ohimege of Koton-Karfe, Alhaji Abdulrazaq Isa-Koto, is also helping us, the local government and all the personnel are helping us.

million (N6.940.081.465.20) offshore and N1.708 billion onshore, totalling N8,648,081,465.2 towards the counterpart funding for the power deal with Siemens AG.

The power agreement was signed by the Nigerian and German governments last year.

The Minister of Finance, Budget and National Planning, Zainab Ahmed, who gave further insight into the anticipatory payment, told State House correspondents that the memo seeking the ratification was jointly presented with her power ministry counterpart, Saleh Mamman, and that it is geared towards the counterpart funding for the bilateral agreement with the German consortium guaranteed by the German government, through Euler Hermes, to finance the implementation of the end to end grid modernisation and expansion programme of the project.

Recall that the Federal Government had, in December, 2019, allocated N61 billion for the Nigeria Electrification Roadmap which would be developed in partnership with Siemens AG.

In July 2019, the government and Siemens signed a letter of agreement on the Nigeria Electrification Roadmap after President Buhari and the German Chancellor, Angela Merkel, met on August 31, 2018, in Abuja.

Nigeria is expected to spend about €3.11 billion or N1.15 trillion across four major states. The Nigerian electrification project has three phases and it aims at achieving 25,000 megawatts of electricity in the country by 2025.

Power projects in the budget include the 3,050 megawatts Mambilla hydropower plant in Taraba State, for which N2 billion counterpart-fund was set aside.

Others are the 2x60M-VA 132/33kV substation at Gwaram in Jigawa State (N717 million); the 215MW power station in Kaduna (N190 million), and the Kashambilla transmission in Taraba (N506 million).

The finance minister explained that the amount was for the first phase of the three-phased project designed to include 23 transmission initiatives as well as 175 separate trans-

formative projects. She said: "So today, at council, we discussed the stage one of phase one of this project under Presidential Power Initiative.

This project is designed to include 23 transmission initiatives as well as 175 separate transformative projects in the electricity distribution franchises that we have in the country.

"The project will also support the regulator, the Nigerian Electricity Regulatory Commission (NERC), to transition towards a programme of improving metering in the electricity industry in the country.

'Let me remind us as citizens that Mr. President and his German counterpart met in Abuja on 31st August 2018 and committed to jointly increase the capacity of the Nigerian electricity grid from current capacity of 5,000 megawatts to 25,000 megawatts over a three-phased programme.

"After this meeting, an MoU was executed on the 23rd of July, 2019 between the Nigerian government and the Siemens AG, with the German government's support.

The MoU is designed to deliver this end to end modernisation programme the 2020 appropriation revised for the government's counterpart funding.

"The Federal Government is taking the loan from the German government with the plan to onlend this particular loan to the distributing network.

'So, it's a convertible loan facility to the DisCos and we will be working with the DisCos to restructure an appropriate loan agreement as soon as we are able to close out on this initial phase of the process. And council approved and ratified Mr. President's approval.'

The FEC also approved the ratification of the Air Transport Agreement between Nigeria and the United States of America.

The air transport bilateral agreement is to strengthen economic, social, and cultural ties between the two countries.

The Minister of Information and Culture, Alhaji Lai Mohammed, who stood in for the Minister

of Aviation, Senator Hadi Sirika, said: "The Aviation Minister presented a memo today (Wednesday) on the approval for ratification of the air transport agreement between the Federal Government of Nigeria and the United States of America.

"The minister sought council's approval for ratification of the air transport agreement between USA and Nigeria.

"You will recall that both the United States and Nigeria are parties to the Chicago Convention on the 7th of December, 1994.

"Article 6 of the convention actually urges parties to sign an air service agreement with member states to improve social, political, and economic ties.

"The US has ratified its own and Mr. President and council graciously accepted today to also ratify this agreement.

"So, today, Mr. President signed a valid agreement of air transport service between Nigeria and the US with the attendant benefits for both countries, especially as Nigeria is working towards having its own full national airline.

"So, we will now take advantage of this air transport bilateral agreement to strengthen economic, social, and cultural ties between the two countries."

Minister of Industry, Trade and Investment, Niyi Adebayo, said council also ratified the president's approval of the Investment **Promotion and Protection** Agreement, signed in 2016 between Nigeria and Singapore on the one hand, and Nigeria and the Kingdom of Morocco on the other hand.

He said: "In 2016, the Attorney-General of the Federation came up with a new model of Investment Promotion and Protection Agreement and that year Nigeria signed based on that new model between

Speaking while addressing a media parley in Lagos, the governor who also raised the alarm that the All Progressives Congress (APC) are already recruiting thugs into the state warned that nobody has monopoly of violence. "What I am saying is that

as a governor of a state, it is not my style to begin to talk about violence and all of that.

"But, I want to say that they should be sensible not to try it because unlike other states, Edo is in the middle of the country and any crisis in Edo today will

have a major effect on other states in the country. And we are ready for it. Our style is not to propagate about it but they want to.

We will not talk about that. Nobody has monopoly of violence. You know you don't want to go that way. With Edo coming into PDP, the South-South is full completely. Even if I don't have the capacity for thuggery, I have enough neighbours and brothers"

He also warned those talking about use of federal might to have a rethink, saying the people of Edo are more than ever determined to protect their votes.

"That is what we are saying today that if we want this democracy to survive, don't play games with Edo election because the moments are different. This is not a general election. It is a sole day election.

'So, everybody will be watching and looking. And if we need anything in Nigeria today, we need a smack of credibility. So, I don't believe people in Abuja are that dumb and crazy not to understand the danger and the crisis we will face if they don't allow the votes count and they want to militarise the election.

"And in any case, the

revealed that four AK-47 rifles, 361 rounds of AK-47 live ammunition, five other weapons of different makes, and one anti-tracking device were recovered from the suspects.

According to Mba, "We have a disturbing and pathetic case involving the kidnap of one Job Ekpo Jonathan, a dispatch rider with Glory Master Logistics, the major distributor of Forever Living Products.

"Job was detailed by his company to go and deliver Forever Living Products to someone who had ostensibly ordered for this product online

"He first of all rode his bike to Ikorodu area of Lagos and eventually was directed to proceed to Sagamu, not knowing that he was walking into kidnappers' den.

'On arriving at the location, which turned out to be a church, Job was immediately taken hostage.

'This gang is run by Pastor Adetokunbo Adelopo, a 52-year-old man of God who is

the General Overseer of New Life Church of God.

"The Pastor had built a beautiful underground facility in his church premises where Job was held throughout the period he was in their captivity.

When Job started struggling with them after they had seized him with a rope on his neck, the pastor, who is neither a doctor, nurse, nor a certified health worker, administered an anaesthesia forcefully on Job, which made him unconscious.

'Other members of the gang who actively participated in that operation are Chigozie Williams, 22 years old, from Umuahia North Local Government Area of Abia State; Linus Ugorji, 30 years old, from Ezinifiti community in Imo State, and Emmanuel Chris, 27 years of age, from Imo State.

"It is a highly diversified gang with members from different states of the federation.

The victim, Job, who nar-

rated his ordeal to newsmen, said he spent 10 days in their captivity inside an underground hole which they called Special Guest House, where he was only fed with garri, sugar and beans.

According to him, "When I got to the church to deliver the items, they suddenly put a rope around my neck from the back and I started shouting the blood of Jesus and struggling to free myself from the rope.

"All of them started shouting blood of Jesus to confuse neighbours while trying to tie my hands. When they finally brought me down, the pastor now injected me, and that was the only thing I remember.

"They were feeding me with garri, sugar, beans, coke and water. I spent about nine days in that hole and was rescued by the police on the 10th day. I had never experienced such a thing before.'

While speaking with newsmen, Pastor Adetokumbo Adelopo, who said he had spent over 20 years in the ministry. also claimed to have been ordained in 2014 as a resident pastor with Living Faith Chapel, which he resigned from to start his ministry, New Life Church of God.

According to him, he resigned from Living Faith Chapel because he was not having time to do charity works which he enjoyed doing.

He said: "I was ordained a pastor by Bishop Abayomi in Ibadan in 2014. We do a lot of charity in my church and during this COVID-19 pandemic lockdown, I didn't have anything in my account and people were still coming for help. I don't take care of Christians alone; I do take care of Muslims too.

"We needed money to buy foodstuffs and ram for this Sallah. So, it was from there I decided to source money from this company by kidnapping their staff.'

He, however, denied the involvement of Living Faith Chapel in his criminal activity, saying it had nothing to do with his present life. "I left them long ago."

Governor Muhammadu Badaru Abubakar of Jigawa State has assented to the revised 2020 budget, with a pledge to stick to financial discipline and implementation in line with budgetary policies.

The reversed budget was reduced from N153.920billion to N124.357 billion, a drop of about N28.5billion, representing 19 per cent drop in the size of the budget.

According to him, the reduction was not peculiar to the state budget alone as it also affected the local government budget from N72.5b to now N56.2 b, a drop of about 16.33 per cent.

He stated that this was necessary to attend to other extra spending, especially as 13 per cent of the budget would be dedicated to COVID-19 pandemic, other business stipulations, among other specific spending

Shedding more light on the budget, the finance commissioner, Hon. Babangida Umar Gantsa, said the original budget size was N103b, but was later reduced to N123.4b, amounting to the reduction of 19 per cent.

For that of local government budget, it was reduced from N72.21b to N56.21b, which was by 17 or 23 per cent of the budget size.

He attributed the revision of the budget to COVID-19 pandemic, which had affected the world economically, leading to the drop in the oil revenue, which crashed from \$27 per barrel to \$18 per barrel, which actually necessitated the revision of the budget proposals.

ormer Vice Presi-dent of the Nigeria Football Federation (NFF), Victor Baribote, has berated the decision of the NFF to annul the Anambra Football Association election held on Monday, July 27.

Thunder Balogun, Nigeria's Greatest Footballer – Onigbinde

Two-times chief coach of the Super Eagles, Chief Adegboye Onigbinde, has insisted that, the late Teslim 'Thunder' Balogun, remains the best footballer ever produced by Nigeria, as the Balogun family today July 30, 2020, remembers the soccer legend in his 48th year memorial, when he died in his sleep in 1972.

The former FIFA and CAF Instructor, noted that: The greatest footballer Nigeria has ever produced was Teslim 'Thunder' Balogun.

"There is no doubt about it. As a footballer, he did many things players do before his time, those of his time and after and even years to come did not do and have not been able to do with the ball.

"The greatest goal scored by any player I have seen played football was scored by 'Thunder' Balogun at the Olu Ibadan Stadium in 1968 in the match between the Nigerian national soccer team, the UK Tourists and England.

"The English players were always on him each time he received the ball. To beat the pressure off, 'Thunder' stood outside the 18-yard box with his back turned at the England goalkeeper.

"A ball was floated to him from the midfield and the English players were waiting for him to bring it down.

"But against their imagination, he staggered a bit, and in turning, he fired a shot at the goalpost, which saw the goalkeeper diving the other way while the ball

season.

was already shaking the net," Onigbinde stated.

The former Trinidad and Tobago coach stressed that, "the story of 'Thunder' Balogun will never die. For

those of us who watched him play, we saw him as Nigeria's greatest footballer." Onigbinde noted: "He died in his sleep on July 30,

1972 at the relatively young age of 45, but the heroics of Thunder Balogun lives forever. Everybody called him Thunder Balogun but at birth he was named Tesilim Akanni Balogun. His father was a cricketer.

He attained legendary status after he became the first Nigerian to play professional football in England."

Teslim played for Apapa Bombers, Marine, Railway, Plateau, Pan Bank and Dynamo all between 1944 and 1961

"He won the FA Cup five times in seven final appearances and was the first player to score a hat-trick in the FA Cup final when he put three goals past Warri XI as Pan Bank won the 1952 final 6-1.

"In 1949, he was part of Nigeria's first national team, known as the UK Tourists team that toured the United Kingdom. After that encounter he signed for Peterborough FC, becoming the first Nigerian to play professional football in England.'

Balogun also had professional stints with Holbeach and Queens Park Rangers where he played 13 times and scored 3 goals in 1956.

His playing career lasted from 1945 to 1962 and he was in the coaching crew for Nigeria to the 1968 Olympic Games where the country drew 3-3 against Brazil.

ote: Seldom would I return to a topic after signing off on it. But, my advocacy for OKONJO-IWEA-LA FOR PRESIDENT has come under attack from people who mean well for Dr Ngozi Okojo-Iweala without asking if this is the best thing for Nigeria. Forgive me therefore for returning so soon to it.

"FG inaugurates WTO campaign team for Okonjo-Iweala.'

The July 24, 2020 report announced that "The Minister of Industry, Trade, and Industry, Richard Adebayo, inaugurated the team in Abuja "to support Ngozi for the position of Director-General of the World Trade Organisation". Earlier, Obadiah Mailafia, had joined the bandwagon of those urging Ngozi to run. It would not be the first time Nigerians would give "massive support" to her when vying for global posts against other contestants. I recollect when the World Bank top job was open about eight years ago (I cannot be more precise because of my health challenges which make it impossible for me to reach my archives in Oyo State). Havingreached the position of one of the Managing Directors of the global bank, Nigerians thought she could be considered for the job.

I recollect asking my Fellow Nigerians to forget the idea for one simple reason well known to Ngozi and Obadiah also. When the two global institutions-World Bank and International Monetary Fund, IMF, were created at Breton Woods, USA, at the end of the Second World War, the entire world conceded the Presidency of the World Bank to the USA and the Managing Director of the IMF to Western Europe. Our agitation for Ngozi to aspire to World Bank Presidency therefore amounted to national collective folly and I said so. One fellow at the time interpreted that to mean I was not a patriotic Nigerian until I sent him a copy of the original global agreement. It was the same agreement which conferred on the US dollar the status of international reserve currency. All international trade has since then been conducted on dollar prices.

It is not clear to me if the post of the Director-General of WTO is restricted in any way according to the agreement establishing it. If there is a specific clause excluding a Nigerian or African for that matter, from vying for the job, our candidate will never clinch it. Instead, we would only once again appear to be collectively stupid. I dissociate myself from thoughtless mob action.

However, even if she is totally qualified to head WTO, I will still regard her being shunted off to WTO as a move not totally in the national interest for two reasons. First, apart from getting Ngozi another well-paid job, it is not a really powerful position and her ability to influence events in favour of Nigeria are limited. Dr Akinwunmi Adesina's problems at the African Development Bank is a pointer to what she will face. Second, and Mailafia should understand this point. From the standpoint of comparative advantage, being President is far more useful for Nigeria than as DG-WTO. Two recent announcements by the Federal Government should prove to us why she is needed at home not Europe.

Open Letter To Prince Arthur Eze On Okonjo-Iweala

"Only God can make an Igbo man President. We shall pray to God to find an Igbo man who has the character to help the people. I would prefer someone who has conscience; someone who will remember me. I don't care where you come from." Prince Arthur Eze, PUNCH, back page.

Before addressing the statement credited to Prince Eze, let me, in case he gets to read this open letter, inform him and other readers that this advocacy actually had its origin in a Northern living room. I had gone for an appointment. Just before me was an Igbo man. Our host is a powerful mobiliser of people. The three of us ended having lunch during which the conversation turned to Igbo Presidency-which our host thought is overdue. We ended with the question: who is a credible candidate? I promised to search for one. I had presented the Chairman of Air Peace and Mr Tony Elumelu before. I still regard them as good candidates. Then, I ran a projection through my computer and discovered that Nigeria's debt burden might increase by 100 per cent in three years. Who would help us in 2023? The name Dr Ngozi Okonjo-Iweala suggested itself. That brings me to Prince Eze's statement which can be divided and answered in three parts.

First, I agree that "Only God can make an Igbo man President". But, I also believe that God helps those who help themselves. Prince would not be a billionaire if he had been sitting at home and praying. Prince Tony Momoh, ex-Minister for Information once pronounced that "Work is prayer in action." If we want an Igbo President, we must work for it.

Second, Gowon, Obasanjo, Shagari, General Buhari in 1983, Obasano again, and Yar'Adua were selected by human beings, perhaps doing God's work. The assassination of General Aguyi Ironsi, by Northern soldiers on "revenge mission" led to the selection of Gowon in 1966 – who led the country until 1975. The assassination of his successor, General Murtala Mohammed, by Colonel Dimka and a few dissidents resulted in a man-hunt organised by the Army High Command for Lt-General Olusegun Obasanjo, the most senior officer. Murtala's second in command had run away to hide after his boss was killed. He played no role in putting down the coup attempt by Dimka. Major-General Danjuma, the Chief of Army Staff, could have installed himself as Head of State. But, the Officer and Gentleman ordered for Obasanjo to be brought from hiding to become Head of State.

Preparatory to the return to civil rule, the military lifted the prohibition on political activities. While all the other parties very quickly settled the important matter of Presidential flag-bearer, the National Party of Nigeria's, NPN, convention was deadlocked. No declared candidate was able to gather a majority of the delegates' votes. Suddenly, a Northern chieftain of the party got up; consulted with Alhaji Shehu Shagari and a few other leaders of the party. That was how Shagari emerged as the Presidential candidate of the NPN and the first elected President of Nigeria in 1979.

Contrary to widespread rumours, Major-General Buhari was not the leader of the December 31, 1983 coup which toppled the Shagari administration and brought him to ultimate power the first time. He was invited to lead after the coup had succeeded. This is not the time and place to name the coup plotters.

Finally, Obasanjo was in prison; he was not one of the founders of the Peoples Democratic Party, PDP, when, again, there was another return to civil rule in 1998. He was released from jail; pardoned and funded by earthly powers to take over the party. (See details in my book PDP: CORRUPTION INCORPORATED).

More evidence has come into the public domain since the first part of this article was written. One of them is with regard to the suspension of twelve directors of the Economic and Financial Crimes Commission, EFCC. Let me make just a brief comment for now-based on my gut feelings.
